

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. HOW TO ENTER: Good Housekeeping's Universal Orlando Resort Summer Sweepstakes (the "Sweepstakes"): To enter beginning July 1, 2017, at 12:01 AM (ET), through August 27, 2017, at 11:59 PM (ET) (the "Entry Period"), go to summersweeps.goodhousekeeping.com on a computer or wireless device and complete and submit the entry form pursuant to the onscreen instructions. Important Notice: You may be charged for visiting the mobile website in accordance with the terms of your service agreement with your carrier. Please consult your wireless service provider regarding your pricing plan. You must use a Smartphone device to participate via your mobile phone. Not all mobile phone providers carry the necessary service to participate. Check your phone capabilities for specific Internet instructions. If your data usage exceeds what is allotted by your data plan, you could be subject to additional fees by your carrier. Please contact your mobile service provider with any questions regarding your bill. **Winner Selection:** Winner (individually and collectively, the "Winner") will be selected within one (1) month from the end of the Sweepstakes in a random drawing from among all eligible entries received. In the event the Sponsor does not receive any eligible entries, the Sponsor has the right to cancel the Sweepstakes. Drawing will be conducted by Good Housekeeping magazine, whose decisions are final. Odds of winning will depend upon the total number of eligible entries received. **Prizes & Approximate Retail Value ("ARV"):** One (1) Winner will receive a four (4) day, three (3) night trip for Winner and up to three (3) guests ("Guest") to Universal Orlando Resort™ in Orlando, Florida ("Trip"). Trip will include: (i) round trip economy class air transportation for Winner and up to three (3) Guests from a major commercial airport near Winner's home (as determined by Prize Provider in their sole discretion) to Orlando, FL; (ii) three (3) nights standard hotel accommodations (one room, quadruple occupancy, room and tax only) at Loews Sapphire Falls Resort or at another on-site hotel (as determined by Prize Provider in their sole discretion); (iii) non-exclusive ground transportation to and from airport and hotel in Orlando, FL; (iv) 3-Park 3-Day Park-to-Park theme park tickets for admission to Universal Studios Florida and Universal's Islands of Adventure theme parks and Universal's Volcano Bay water theme park for Winner and up to three (3) Guests; (v) 1-Day 2 Park VIP Experience guided tour (non-private) through Universal Studios Florida and Universal's Islands of Adventure for Winner and up to three (3) Guests; (vi) and admission to one (1) Blue Man Group Show (exact date and time to be determined by Prize Provider in their sole discretion) for Winner and up to three (3) Guests. **The Approximate Retail Value ("ARV") of Prize is Four Thousand Three Hundred and Fifty Six Dollars and 94/100 (\$4,356.94), which may vary depending on location of Winner's residence.** Any difference between the stated ARV and the actual value of the prize will not be awarded in any form. For a winner who is a Florida resident, an alternate method of transportation for Winner and Guests may be substituted for air transportation by Prize Provider in its sole discretion. Trip must be booked at least sixty (60) days prior to intended departure date. Travel dates are subject to Prize Provider and Sponsor approval. If applicable, inaccurate, lost, late, misdirected, damaged, manipulated, incomplete or entry forms that have been tampered with will be disqualified. Online entrants must have valid email address and it is entrant's responsibility to update Sponsor of any change in email address. If there is a dispute as to the identity of an online entrant, the prize will be awarded to the authorized account holder of the email address. The "authorized account holder" is defined as the natural person to whom the email address is assigned by an internet service provider, online service provider, carrier, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning the email addresses for the domain associated with the submitted email address.

Winner hereby further agrees that it will sign any documents necessary to transfer copyright of his/her submitted entry, if applicable, to Sponsor within five (5) business days following the date of first attempted notification. INTERNET/MOBILE: Sponsor is not responsible for electronic transmission errors resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions or limitations of any kind, or inaccurate transmissions of or failure to receive entry information by Sponsor or presenter on account of technical problems or traffic congestion on the Internet, at any Web site, or via the mobile phone or any combination thereof. If for any reason the Internet or mobile phone portion of the program is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes. Sponsor reserves the right to select Winners from eligible entries received as of the termination date. Sponsor further reserves the right to disqualify any individual who tampers with the entry process. Sponsor may prohibit an entrant from participating in the Sweepstakes if it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception or other unfair playing practices or intending to abuse, threaten or harass other entrants. DISPUTES/CHOICE OF LAW: Except where prohibited, each entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in New York, NY; provided, however, that claims for bodily injury, personal injury, or property damage arising out of the redemption, use or misuse of any prize must be submitted to the jurisdiction and venue of the federal and state courts of the State of Florida, and construed and enforced in accordance with the laws of the State of Florida; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and (3) no punitive, incidental, special, consequential or other damages, including without limitation lost profits may be awarded (collectively, "Special Damages"), and (4) entrant hereby waives all rights to claim Special Damages and all rights to have such damages multiplied or increased.
