

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. HOW TO ENTER: Cosmopolitan's Halloween Sweepstakes (the "Sweepstakes"): To enter beginning September 1, 2018, at 12:01 AM (ET), through September 16, 2018, at 11:59 PM (ET) (the "Entry Period") go to halloweensweeps.cosmopolitan.com on a computer or wireless device and complete and submit the entry form pursuant to the onscreen instructions. **Important Notice:** You may be charged for visiting the mobile website in accordance with the terms of your service agreement with your carrier. Please consult your wireless service provider regarding your pricing plan. You must use a Smartphone device to participate via your mobile phone. Not all mobile phone providers carry the necessary service to participate. Check your phone capabilities for specific Internet instructions. If your data usage exceeds what is allotted by your data plan, you could be subject to additional fees by your carrier. Please contact your mobile service provider with any questions regarding your bill. **Winner Selection:** Winner (individually and collectively, the "Winner") will be selected on September 17, 2018 in a random drawing from among all eligible entries received. In the event the Sponsor does not receive any eligible entries, the Sponsor has the right to cancel the Sweepstakes. Drawing will be conducted by Cosmopolitan magazine, whose decisions are final. Odds of winning will depend upon the total number of eligible entries received. **Prizes & Approximate Retail Value ("ARV"):** One (1) Winner will receive a four (4) day, three (3) night trip for Winner and up to three (3) guests ("Guest") to Universal Orlando Resort™ in Orlando, Florida ("Trip"). Trip will include: round trip economy class air transportation for Winner and up to three (3) Guests from a major commercial airport near Winner's home (as determined by Prize Provider in their sole discretion) to Orlando, FL; three (3) nights standard hotel accommodation (one room, quadruple occupancy, room and tax only) at Universal's Aventura Hotel or at another on-site hotel (as determined by Prize Provider in their sole discretion); non-exclusive ground transportation to and from airport and hotel in Orlando, FL; 3-Park 3-Day Park-to-Park tickets for admission to Universal Studios Florida, Universal's Islands of Adventure and Universal's Volcano Bay Water Theme Park for Winner and up to (3) Guests; one (1) day Halloween Horror Nights™ General Admission Tickets for Winner and up to three (3) Guests; one (1) day Halloween Horror Nights™ Express Passes for Winner and up to three (3) Guests; and admission to one (1) Blue Man Group Show (exact date and time to be determined by Prize Provider in their sole discretion) for Winner and up to (3) Guests.

The Approximate Retail Value ("ARV") of Prize is Four Thousand Three Hundred Eighty Three and 56/100 Dollars (\$4,383.56), which may vary depending on location of Winner's residence. Any difference between the stated ARV and the actual value of the prize will not be awarded in any form.

Travel must coincide with Universal Orlando's 2018 or 2019 Halloween Horror Nights dates in order to partake in the Halloween Horror Nights portion of the Prize. 2018 event dates occur on select dates between September 14, 2018 and November 4, 2018. 2019 event dates are currently to be determined. If Winner is unable to travel during this time period, Winner may choose to travel at another time (with Prize Provider approval) with the understanding that in doing so Winner will forfeit the Halloween Horror Nights elements of the Prize Package. Trip must be completed by November 10, 2019 or Prize will be forfeited in its entirety and no further or alternative compensation will be provided. For a winner who is a Florida resident, an alternate method of transportation for Winner and Guests

may be substituted for air transportation by Prize Provider in its sole discretion. If Winner is between the ages of eighteen (18) and twenty-one (21), he/she must be accompanied by an adult of at least twenty-one (21) years of age in order to check into the on-site hotel. Airfare will vary depending on factors that will include, but not be limited to, the Winner's proximity to the prize location; any difference between stated ARV and final ARV of Prize will not be awarded. In the event that any one or more potential Winner(s) fails to respond as stated above, declines the prize, or fails to provide signed affidavits or releases, such Winner(s) will be deemed to forfeit the prize and Sponsor will select an alternate Winner(s) from the remaining eligible entrants. 3. ENTRIES: Limit one (1) entry per email address per day for Sweepstakes. Multiple entries from the same person on the same day will be disqualified. Entries become the property

of the Sponsor and will not be returned. Proof of submission does not constitute proof of receipt. If applicable, inaccurate, lost, late, misdirected, damaged, manipulated, incomplete or entry forms that have been tampered with will be disqualified. Online entrants must have valid email address and it is entrant's responsibility to update Sponsor of any change in email address. If there is a dispute as to the identity of an online entrant, the prize will be awarded to the authorized account holder of the email address. The "authorized account holder" is defined as the natural person to whom the email address is assigned by an internet service provider, online service provider, carrier, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning the email addresses for the domain associated with the submitted email address.

Void in Puerto Rico and where prohibited by law. Winner hereby further agrees that it will sign any documents necessary to transfer copyright of his/her submitted entry, if applicable, to Sponsor within two (2) business days following the date of first attempted notification. INTERNET/MOBILE: Sponsor is not responsible for electronic transmission errors resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions or limitations of any kind, or inaccurate transmissions of or failure to receive entry information by Sponsor or presenter on account of technical problems or traffic congestion on the Internet, at any Web site, or via the mobile phone or any combination thereof. If for any reason the Internet or mobile phone portion of the program is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes. Sponsor reserves the right to select Winners from eligible entries received as of the termination date. Sponsor further reserves the right to disqualify any individual who tampers with the entry process. Sponsor may prohibit an entrant from participating in the Sweepstakes if it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception or other unfair playing practices or intending to abuse, threaten or harass other entrants. Damages and all rights to have such damages multiplied or increased. New York State law, without reference to New York's choice of law rules, governs the Sweepstakes and all aspects related thereto.
