

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **HOW TO ENTER:** Good Housekeeping Alaskan Magic Sweepstakes (the "Sweepstakes"). To enter beginning November 1, 2018, at 12:01 AM (ET), through December 15, 2018, at 11:59 PM (ET) (the "Entry Period"): (i) Go to magic.goodhousekeeping.com on a computer or wireless device and complete and submit the entry form pursuant to the onscreen instructions; or (ii) text MAGIC to 246810 to receive a link to the online entry form, and complete and submit the entry form pursuant to the onscreen instructions. By participating, you consent to receive a single text message sent through an automatic telephone dialing system, providing a link to the Sweepstakes entry form from Sponsor and/or its affiliates. **Important Notice:** Standard message and data rates may apply. 2. **WINNER SELECTION:** One (1) Winner (individually and collectively, the "Winner") will be selected on or about December 17, 2018, in a random drawing from among all eligible entries received during the Entry Period. In the event Hearst Communications, Inc., the sponsor of the Sweepstakes ("Sponsor"), does not receive any eligible entries, the Sponsor has the right to cancel the Sweepstakes. Drawing will be conducted by Good Housekeeping Magazine, whose decisions are final. Odds of winning will depend upon the total number of eligible entries received. If there is a Canadian Winner, the Winner will be required to correctly answer a mathematical skill testing question as a condition of receiving the prize.
3. **PRIZE & APPROXIMATE RETAIL VALUE:** One (1) Winner will receive a seven (7)-night Alaskan *Disney Cruise Line* vacation aboard the *Disney Wonder* for Winner and up to three (3) Guests (the "Prize"). availability; certain restrictions and blackout dates may apply. Travel may not occur during cruise ship or airline block-out periods. Please go to www.disneycruise.com to view available sail dates. Winner must travel on dates specified by Sponsor. Arrangements must be made at least 45 days prior to departure. Once scheduled, the itinerary cannot be altered and failure of Winner to follow such a schedule shall not obligate Sponsor in any way to provide the Winner with alternate arrangements. If any alternate(s) similarly fails to respond or declines the prize, Sponsor will use a reasonable number of attempts, in its discretion, to award the prize(s) to
